The Social Justice Studies Program at the University Of Victoria seeks Sessional Instructor(s) for September 2026 for SJS 400: *Social Justice in Action*.

Course Description: An advanced interdisciplinary exploration of key action-oriented approaches, strategies and tactics for engaging with contemporary social justice movements.

September 9 – December 7, 2026

Mondays and Wednesdays 2:30-4:00pm

Some additional meeting time outside of the instructional hours (prior to and following the course) is required.

**Qualifications:**

Candidates must have teaching experience at the undergraduate level. A completed MA or PhD in a relevant field is required. Candidates who are ABD are also encouraged to apply. Preference will be given to applicants who have experience teaching in a field closely related to Social Justice Studies.

After hiring is completed, instructor(s) will work with the Social Justice Studies program to finalize the course syllabus. All qualified candidates are encouraged to apply; however, in accordance with Canadian Immigration requirements, Canadian citizens and permanent residents will be given priority.
