Anyone interested in taking the CBIS Program is required to complete this Application for Admission form. There is an application fee of \$60. If your intent is to take an individual course, no application is required.

WITHDRAWALS AND REFUNDS

All courses in the CBIS Program have limited enrollment.

Students who wish to withdraw from a course must notify the CBIS Program administration staff prior to the final day of class to ensure that they are removed from the class list and are not awarded a failing grade.

Students who wish to withdraw from a course within six calendar days of the course start date will be eligible for a refund of their course fees, less a \$60 administration fee. Withdrawal requests received after this period will not be eligible for a refund.

Instructors are approved by the program steering committee and evaluated by the students.
